⁶⁾ Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 2,640 shall be charged for the first passport and DKK 1,130 or DKK 1,782 for subsequent passports.

⁷⁾ Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 3,770 shall be charged for the first passport and DKK 1,130 or DKK 1,782 for subsequent passports.
